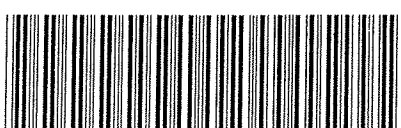

On the 27th day of January, 2017, the Grand Jury, having returned a "No True Bill" in the above entitled case, submit the following report pursuant to the requirements of Neb. Rev. Stat. §29-1406(2)(g)(i).

Findings: Hall County Grand Jury convened as directed by Judge Teresa Luther on January 27, 2017. The principle duty was to investigate the circumstances surrounding the death of Moises Tino-Lopez and to ascertain if any crime or crimes were committed by any parties therein involved. The jury, in its course of investigation, met on January 27, 2017. There was witness testimony as well as exhibits offered. It has been determined that:

§ 27 4 45

Jail and medical personnel responded to Moises Tino-Lopez at the Hall County Department of Corrections regarding a seizure. Mr. Tino-Lopez did not respond. It was noted that Mr. Tino-Lopez had not been taking his antiseizure medication. The medical records indicated possible prior history of seizures. Treatment was rendered at the jail, and Mr. Tino-Lopez was transported to St. Francis Medical Center for further treatment. Mr. Tino-Lopez was declared brain dead on September 23, 2016, and his heart stopped beating on September 27, 2016. Jail and medical personnel responded appropriately to their practices and procedures. An autopsy was performed, and the manner of death was determined to be natural causes.

The Grand Jury finds no criminal conduct on the part of law enforcement and returns no true bill.

Recommendations: None.

The no true bill and the grand jury report shall be filed with the court, where they shall be available for public review.
